# **Enabling Safe certification of deaths**

A GM team has been set up to assist GPs with the death reporting process during the Covid 19 pandemic. I have attached a flowchart, which may help the understanding of this process, with thanks to Dr Joanna Bircher who put this document together.

Please be aware that although covered by this service, this information is not exactly the same for the practices in Glossop and the High Peak, as they have a different process in place as dictated by the Senior Coroner for Derbyshire, Dr Robert Hunter and do not have to use a Statement of Intent nor review the Sol every 28 days.

### Children's health during the COVID 19 pandemic

Our colleagues at Wessex LMC have shared the following important information:

Wessex LMC has been working closely with one of our local Paediatricians, Dr Sanjay Patel a Consultant in Paediatric Infectious Diseases at University Hospital Southampton, he has been working with the **The Royal College of Paediatrics and Child Health (RCPCH)** they are keen to get the following message not only to general practice but also to your patients with children. Sadly, the RCPCH have received information about a number of cases where delayed presentation of unwell children by parents may have contributed to significant adverse events (includes **deaths from sepsis**, appendicitis etc). There have also been reports of increasing rates of non-accidental injury associated with this period of lock-down.

It is really important for all healthcare professionals to appreciate that COVID-19 is extremely unlikely to cause severe illness in a child (data from China, Italy, UK) — most children exhibit very few or no symptoms when infected with SARS-COV2 so one cannot assume that an unwell child or a child with fever >5 days has COVID-19 and an alternative diagnosis must be considered. It is essential also that this message gets to parents and that if they have an unwell child, they must continue to seek healthcare support.

#### **Notice on COPI regulations 2002**

As I'm sure you're aware, a notice has been served on the Healthcare Control of Patient Information 2002 regulations. This Notice means that it is a requirement to share and process patient data for a COVID 19 purpose. For ease of reference, I have attached the notice.



#### Graphnet

As regulated by the COPI regulation, health data will be shared at a GM level via Graphnet. Graphnet was enabled in Oldham via the Oldham Shares project. It is currently being urgently mobilised in the T&G area and once the current pandemic subsides, a full retrospective DPIA (Data Protection Impact Assessment) will be conducted. Please be aware that Graphnet uses coded data only and data related to sexual health, HIV and AIDS and Termination of pregnancy is excluded from this data.

# **GP Connect CCAS**

A national requirement for data sharing and processing is the GP Connect CCAS. The CCAS (Covid-19 Assessment Service) is to be run by returning retired GPs, who will need to access patient health records via GP Connect. NHS Digital have recently run webinars for EMIS and TPP system users, which you may have already completed. If you require any further information, please do not hesitate to contact me.
