COPI Notice

The Notice served under Regulation 3(4) of the Health Service Control of Patient Information Regulations 2002 (the COPI Notice) has mandated data sharing and processing for a Covid-19 purpose. That Notice is set to expire on September 30th, 2020, although there is talk of it being extended until December 2020. I will let you know as soon as a decision has been made about that.
